1. Introduction about EEA

The Ethiopian Economics Association (EEA) was established as a non-profit, non-partisan and non-religious Professional Association in 1991. The EEA has a vision of becoming the premier economics association in Africa renowned for its excellence in membership services and economic policy research. Its objectives are organized around six main dimensions: support economic policy design through capacity building; enhance economic research and dissemination; promote the discipline of economics; serve as a platform for dialogue on economic issues; promote the professional interest of its members; and facilitate professional linkages between Ethiopian economists and those of other countries.


In order to advance and fulfil its vision and objectives, the EEA has established the Ethiopian Economic Policy Research Institute (EEPRI) in 2000. The EEPRI has enabled EEA to conduct independent and good quality research and provide advisory services both to the federal and regional governments, as well as other stakeholders. It has also established seven Regional Chapters in different Regional States of the country aiming to provide coordinated technical services to policy makers, practitioners, its members, and other stakeholders. The Association in collaboration with the Regional Chapters and Regional Universities organizes annual regional conferences to create a venue for region-specific presentation and discussion of research findings This has also become an important regional platform that brings together regional policy makers, practitioners, and researchers.

EEA has conducted several independent policy-oriented researches as part of its core-research undertakings, collaborative research, and commissioned or demand-driven research activities (some of these are annexed at the end). The research outputs of the Association have been disseminated to policy makers, researchers and practitioners through organizing different discussion forums including workshops and conferences (both at national and regional levels), public lectures and other similar events, and through its various publications. EEA has had strong record in its various activities (research, trainings, public dialogue and publications).

The EEA has enjoyed financial support from several bilateral and multilateral development partners for its core programs. Some of these include the Irish Aid, the Department for International Development (DFID) of UK, the Netherlands Development Cooperation, Swedish International Development Agency (SIDA), Norwegian Agency for Development (NORAD), the African Capacity Building Foundation (ACBF), IDRC, Friedrich Ebert Stiftung (FES), United States Agency for International Development (USAID), International Food Policy Research Institute (IFPRI), Bill & Melinda Gates Foundation (BMGF), Open Society Initiative for Eastern Africa (OSIEA), and the European Union,

2. Organizational Structure

EEA has transparent and accountable governance structure. The General Assembly (GA) of EEA, the highest decision-making entity, is responsible for providing the overall strategic guidance. It determines the policy direction of the Association; deliberates upon and approves the annual performance report including audited annual financial report, the annual plan and its program of action, and annual budget of the association. The Association holds the GA meeting once in a year. The GA also gives strategic guidance to the Executive Committee (EC) of EEA, which are elected volunteers serving a maximum of two terms (six years). The EC by the bylaw is an oversight organ of the General Assembly, it offers policy direction, and approve strategic issues. The Chie Executive Officer (CEO) is appointed by the EC and accountable to the EC. The CEO is responsible for the day to day, strategic, and coherent functioning of the EEA activities. The CEO leads four functional units: Research and Policy Analysis, Partnership and Communications, Administration and Finance, and Income Generating Activity (IGA).



Note: The Research and Policy Analysis Division has six thematic research areas, Macroeconomy; Agricultural and Rural Transformation; Welfare and Human Development; Trade and Industrial Development, Institutions, Environment and Climate Change; and Gender and Women Economic Empowerment.
