Editorial Policy

Aims and Scope

The Ethiopian Journal of Economics is a peer reviewed research journal hosted by the Ethiopian Economics Association. It is published semi-annually in October and April.

The Ethiopian Journal of Economics (EJE) published theoretical and empirical research in the field of economics focusing mostly on the Ethiopian Economy. Published articles mostly focus on development related issues including agricultural productivity, firm productivity, fiscal and monetary policy, poverty reduction, health and education, trade and investment. In general, it publishes research that contributes to evidence based policy in developing countries in general and Ethiopia in particular.

Article Submission

Manuscripts should ONLY be submitted electronically in Microsoft Office Word format as an attachment via e-mail to the EJE editor via eje@eea-et.org, rahel.yilma@eea-et.org, ethiopianeconomicsass@gmail.com. In order to facilitate review manuscript submissions in PDF format is not permitted. For further information please refer the attached Author's Guide.

Authorship

All individuals listed as authors for submitted manuscripts are required to have contributed substantively. Substantive contribution includes conceptualizing the research idea or content, writing and critically editing the manuscript and/or participate in the data analysis. All authors should be thoroughly familiar with the substance of the manuscript and should be able to defend the conclusions of the article. Individuals who have marginally contributed to the manuscript may be mentioned in the Acknowledgement section of the manuscript

Originality

All submitted manuscripts must be original. The journal will not consider manuscripts that are already published or are under publication by another journal. Manuscripts that are published as conference proceeding can be considered for publication if they pass through substantial revisions. By submitting a manuscript, the author(s) certify that the article is not under publication or has not been published on another journal.

Review Process

All manuscripts are desk reviewed by the editors before being sent to reviewers. The journal reserves the right to reject manuscripts at this level if the editors deem it is not at the level to be sent to reviewers. Manuscripts that pass this stage will be sent for blind peer review to two anonymous reviewers. Upon receipt of comments and decision it is sent to the corresponding author. Reviewers have the option of making one of five decisions, accept as is, accept with minor revisions, accept with moderate revisions, accept with major revisions or reject. Manuscripts accepted with revisions need to address all issues raised by the reviewers to be finally accepted for publication.

Copy and Language Editing

The journal editorial and secretariat edits manuscripts to prepare them for publication. The Journal also commissions for language editing depending on the need. Authors should avoid sexual and racial bias and should use gender-inclusive language in their manuscripts
