#### Eleventh International Conference on the Ethiopian Economy Held

The Ethiopian Economics Association (EEA) organized the Eleventh International Conference on the Ethiopian Economy which was held from July 18-20, 2013 in its Conference Hall in Addis Ababa. The conference was co-organized by the Ethiopian Strategy Support Program (ESSP II) of the International Food Policy Research Institute. The threeday conference attracted about 600 participants from

> Fifth Round of the Ethiopian National Health Accounts (NHA) Household Survey: This project aims at conducting the fifth round National Health Survey. The survey data is expected to reveal the health expenditure at household level. It is a collaborative project with Abt. International.

> Ethiopian Project on Interlinking Insurance with Credit in Agriculture (EPIICA): It aims at providing insurance and credit to the vulnerable farming population.

The Ethiopian Economics Association organized a three day workshop on one of its projects entitled "Technology (ex-ante) assessment and farm household segmentation for inclusive poverty reduction and sustainable growth in agriculture" which was held from April 18 –20, 2013 in Addis Ababa. More than 25 scholars from different countries attained the workshop.

#### The purpose of the workshop was to:

I. discuss the state of research activities and approaches followed by the partners of the TIGA project

2. present & discuss methods for the selection of the study site and segmentation

3. make suggestions for research activities for the next phase of the TIGA project.

During the workshop, two invited scholars from IFPRI and SG-2000 presented papers and shared their experiences.

### EEA organized Regional consultation Workshop on Post 2015 Development

Two rounds of regional consultation Workshop on the Post-2015 Development Framework with Ethiopian CSOs and Stakeholders were held on April 05 at PAN AFRIC hotel, Adama and on May 8/2013 at Debre Damo Hotel, Addis Ababa. The workshops were organized by EEA in collaboration with Poverty Action Network Ethiopia (PANE). About 95 invited participants from Oromiya, Afar and SNNPRS regions and Addis Ababa city Administration attended the workshop. Ato Eshetu Bekele, PANE's Executive Director made introductory statements to highlight the MDG objectives and the project, while Ato Worku Gebeyehu, lead researcher from EEA, presented the overall performance of MDGs, and the post-2015 development framework. The workshop looked at progress on MDG achievement in Ethiopia, identified the key impediments, and discussed the post-2015 development framework. Similar consultation workshops will also be held at national and regional levels. The project was funded by CAFOD/SCIAF.

### STATA software application training for ATA staff

EEA organized short term training on the STATA software application to Agricultural Transformation Agency (ATA) staff from May 08-10, 2013 at EEA training Hall,Addis Ababa. The training was meant to build capacity on software application to research work. During the three day training a total of 15 ATA staff attended the training.
