

Brief Profile and Capabilities of the Ethiopian Economics Association

December 2022

1. The Ethiopian Economics Association in Brief


1.1. Establishment, Vision, and Objectives

The Ethiopian Economics Association (EEA) was established as a non-profit, non-partisan and non-religious Professional Association in 1991. It has also been re-registered and accorded legal personality as a local organization in accordance with the Civil Society Organizations Proclamation (No. 1113/2019) of Ethiopia. The EEA has a vision of becoming the premier economics association in Africa by 2030. Its objectives are undertaking evidence-based analysis (research) on evolving socioeconomic realities, organizing forums and creating chances for discussing economic issues, building capacities of its members and other stakeholders, disseminating outputs through various channels, rendering membership services; and promoting the study of economics in the country's educational institutions and beyond.

1.2. Organizational Structure

EEA has transparent and accountable governance structure. The General Assembly (GA) of EEA, the highest decision-making entity, is responsible for providing the overall strategic guidance. It determines the policy direction of the Association; deliberates upon and approves the annual performance report including audited annual financial report, the annual plan and its program of action, and annual budget of the association. The Association holds the GA meeting once in a year. The GA also gives strategic guidance to the Executive Committee (EC) of EEA, which are elected volunteers serving a maximum of two terms (six years). The EC by the bylaw is an oversight organ of the General Assembly, it offers policy direction, and approve strategic issues. The Chie Executive Officer (CEO) is appointed by the EC and accountable to the EC. The CEO is responsible for the day to day, strategic, and coherent functioning of the EEA activities. The CEO leads four functional units: Research and Policy Analysis, Partnership and Communications, Administration and Finance, and Income Generating Activity (IGA).

In addition, EEA has seven Regional Chapters in different Regional States of the country aiming to provide coordinated region-specific technical services to policy makers, practitioners, its members, and other stakeholders. The Association in collaboration with the Regional Chapters and Regional Universities organizes annual regional conferences to create a venue for region-specific presentations and discussions of research findings.



1.3. Major Activities and Achievements

Under its research undertakings, the Association has six research thematic areas: macroeconomy; agricultural and rural transformation; trade and industrial development; welfare and human development; institutions, environment, and climate change; and gender and women economic empowerment. EEA has conducted several independent policy-oriented research activities as part of its core-research undertakings, collaborative research, and commissioned or demand-driven research activities (some of these are annexed at the end). Through its research outputs, it has managed to positively influence policy makings in Ethiopia and beyond. Research outputs of the association has been widely cited and circulated among policy makers, academia, and the media.

EEA has also been organizing different workshops, conferences, and dialogue forums for disseminating research outputs to policy makers, researchers, practitioners, and the wider public (list of some of such events undertaken in one year period is annexed, Annex 3, just as an example). It has also been organizing such events at regional and international levels. A case in point could be African Regional Meetings of the Econometric Society that the Association has successfully organized twice (in 2014 and 2022). It has also been supporting policy interventions at regional levels of the different regions in Ethiopia. In this regard, it has undertaken several studies in different regions of the country including Afar regional state, Amhara regional state, Oromia regional state, Southern Nations Nationalities and Peoples Regional State, and others. Furthermore, EEA has been offering various short-term training on many topics which have been offered to its members and its stakeholders including to staff of Commercial Bank of Ethiopia, staff of the World Food Program, experts from regional states, experts from different federal line ministries, and others.

It has also been publishing different publications including the Ethiopian Journal of Economics that it has bee hosting since EEA's establishment (currently on its 31st volume), proceedings of different conferences, policy working papers, policy briefs, State of the Ethiopian Economy (its flagship publication being published once in two years), research reports, and others. The Association has the capacity and experience of managing multi-year large grants of up to 1.5 million USD per grant (to mention just from the active projects), and overall annual budget of up to 3 million USD (from multiple sources). EEA has also the capacity and experience to subgrant projects. A case in point could be a Bill & Melinda Gates Foundation project, a project being led by the EEA where there are three sub-grantees (Vassar College from the US, New York University Abu Dhabi, and Addis Ababa University from Ethiopia). Some of the projects that were active during the 2021/22 budget year and projects that have been successfully finalized are annexed (Annex Table 1 and Annex Table 2).

EEA is also a member of global associations and think-tanks like the International Economics Association (https://www.iea-world.org/members/member-associations/), the Southern Voice (https://www.iea-world.org/members/members/), WeProsper Global Coalition for Women's Economic Empowerment (https://www.iea-world.org/weprosper/), and others. EEA has standardized Policy Manual for Protecting Sexual Exploitation and Abuse (PSEA) with standard operating procedures in place for submission and receipt of complaints, reporting, investigation and victim assistance with the aim of ensuring compliance with a zero-tolerance policy. Nationally, EEA is a member of the Civil Society Organization Council, Higher Education Relevance and Quality Council, Executive Committee Member of the Ethiopian Professional Association Alliance (EPAA), Steering Committee member of the Network for Ethiopian Policy Analysis and Research in Agriculture and Food System (NET-PARAF), among others.

Overall, EEA has strong record in its various activities (research, trainings, public dialogue and publications) and hence it has received wider recognition by the public, policy makers, and other stakeholders nationally and internationally.

During its existence as a Professional Association, EEA has enjoyed financial support from several bilateral and multilateral development partners for its core programs. Some of these include the Irish Aid, the Department for International Development (DFID) of UK, the Netherlands Development Cooperation, Swedish International Development Agency (SIDA), Norwegian Agency for Development (NORAD), the African Capacity Building Foundation (ACBF), IDRC, Friedrich Ebert Stiftung (FES), United States Agency for International Development (USAID), International Food Policy Research Institute (IFPRI), Bill & Melinda Gates Foundation (BMGF), Open Society Initiative for Eastern Africa (OSIEA), and the European Union. EEA is very grateful for the generous support that it has been receiving from its partners as these are the cornerstones for EEA's success and recognition. The Association hopes and expects that it will receive continued support from some of these partners and other new partners.

2. Capabilities in Brief

2.1. Health Related Projects Accomplished by the EEA

- Enhancing the Role of Academia in Evidence Generation for Action in Health Care Financing
 in Ethiopia: This project was supported by the USAID and run from 2015- 2018. The following
 research activities were conducted under this project:
 - Outsourcing of non-clinical services in the Ethiopian public hospitals: It was aimed at
 examining the implementation status, effectiveness and the functioning of outsourcing
 of non-clinical services in public health facilities.
 - Assessment of exempted health service provision in public health facilities in Ethiopia:
 it was aimed at examining the implementation status, effectiveness and the functioning
 of health services in health facilities in Ethiopia.
 - Assessment of health facilities' revenue retention and utilization (RRU) on improving quality of health service in public health facilities Part I and II: This was to review the implementation status, effectiveness, and the functioning of health facility's revenue retention and utilization on improving quality of health services.
 - Assessment of the operation of private wings in public hospitals in Ethiopia
 - Measuring efficiency of public tertiary hospitals in Ethiopia
- 2. *Community-based health insurance:* This was also a collaborative project with USAID and undertaken from 2013-2015.
- 3. **Fifth Round Household Survey of the Ethiopian National Health Accounts (NHA):** it was aimed at conducting the fifth-round national health survey. The survey covered 10,000 households. The study was a collaborative project with USAID, Abt. International and Federal Ministry of Health. It was conducted from 2012-2013.
- 4. **Poverty Dynamics, Health Shocks and Coping Strategies in Ethiopia:** It is a collaborative 3 years project with OSSREA, ISS, University of Gottingen, Erasmus University of Leiden and EEA. It aimed to investigate the interplay between health shocks and the financial burden of health care, poverty dynamics and the role of coping strategies.
- 5. Leveraging Water, Sanitation, and Hygiene (WATSAN) Nexus: Synergies, Thresholds, and Trade-offs for a Better Nutrition and Health Outcome in Ethiopia.
- 2.2. Projects supported by the Bill & Melinda Gates Foundation
 - 1. *Global Foundational Analysis to close the Gender Profitability Gap*. It is a 3.5 Years Project with a total budget of USD 1,689,641.00. It will be finalized by next August 2023.
 - 2. **Economic Policy Enabling Environment**. It was a three years project that recently ended. It had a total budget of USD 796,240.
- 2.3. Other projects handled in collaboration with diverse partners. EEA has been undertaking a number of activities with diverse partners for a number of years. Summary of the active ones (and just ending ones) are annexed (Annex Table 1) while those that are accomplished within the last five years are also annexed (Annex Table 2)
