wish to extend profound gratitude to the International Centre for Evaluation and Development organizers of the Evidence to Action Conference and Exhibition held in Kampala, Uganda from September 26 - 30<sup>°</sup> 2022 on the theme: "Adapting innovative evaluation practices for evidence-based decision making during and beyond COVID-19".

Some of the highlights of the discussions which I considered resourceful and relevant borders on reflecting on how we gather, chromize and report our evidence.

The point which emphasizes careful based review of the merits and demerits within our Monitoring Evaluation Accountability and Learning (MEAL) practices is an angle of routine consideration. The other point of interest was the need for developing a full culture of

understanding what MEAL is designed to support from a cognitive perceptive for better decision making based on evidence not from guess or trial and error system. As Emma Nthandose Gausi puts it 'In most projects/ programs the M&E process has been relegated to a data collection and processing ONLY activity. I agreed with the philosophy that data/information is also always done to satisfy donor requirements. Which is anti-thesis to the fact Learning in M&E played which should therefore be prioritized throughout the projects/programs.

That for a MEAL to be supportive of project and / or program, the need for the actors to work together and not in salons, cannot be overemphasized. The architects of MEAL should ensure activities results should be used for programmatic improvements and / or adjustment for the overall decision making to ensure the achievement of the goal of any intervention. Another point of interest was the emphasis on regular feedback mechanism that offers accurate, real time, reliable and openness to stakeholders in the intervention be encouraged at all times. The highlight on reportage being holistic across stakeholders that ensure accurate information are shared about the intervention. most especially to the requisite stakeholders must be a matter of must.

Another take away was about cooperation and acceptance as tools to increase resources mobilization, advocacy that thread on humanitarian values, principles, as well as accountability principles so that the stakeholders are allowed to participate in the culture of changing/ adapting the local procedures, policies and understanding that enhances best quality results of intervention and that harnesses best practices. That Managers and donors need to take interest and ownership of monitoring - to find measures, qualitative as well as quantitative, that look past the current budget and previous results and ask questions, answers to which determine how the programme or project can best attract and retain clients or beneficiaries in the future. "As some of you mentioned, M&E activities often throw up a mass of numbers and comparisons that provide little insight into performance. Rather, they are used for justifying the investment; and may even paint a distorted picture of the reality". Through robust monitoring, this could be controlled.

n E2A Conference organizing committee has been in Addis Ababa, Ethiopia, to hold talks with the Policy Studies Institute (PSI), the African Union(AU), Economic Commission for Africa, UNICEF, Ministry of Planning & Development, Ministry of Tourism, Ministry of Labor & Skills, Ethiopian Statistical Services, Ethiopian Economics Association, Ethiopian **Evaluation Association amongst** other stakeholders and partners to accelerate preparations for the upcoming event.

#### The Committee for the Upcoming E2A Conference Discussed Several Updates and Progress

The Committee for the Upcoming E2A Conference Discussed Several Updates and Progress during a meeting at PSI on June 5, 2023, the organizing committee for the upcoming Evidence to Action(E2A) conference, chaired by Ms. Sara from Uganda, Kampala, discussed various updates and progress related to the event. The committee addressed a number of issues, including security and protocol issues, logistics, communications, visa issues for the event, and conference presentations.

In a recent meeting, the organizing committee for the upcoming conference discussed how to ensure security and a proper protocol for senior officials attending the event. The committee recognized the importance of providing a safe and organized environment for all attendees, especially senior officials who require additional security measures.

The committee also considered the possibility of assigning dedicated security personnel to each senior official to ensure their safety throughout the conference.
